CALL FOR APPLICATIONS TO BE A MASTER AGENT FOR THE BELIZE GOVERNMENT LOTTERIES

Background

The Lotteries programme is administered under the Lotteries Control Act and its associated regulations. The Office of the Prime Minister and Ministry of <u>Investment</u> is responsible for the lotteries portfolio. Since May 2nd, 2023, the Government lotteries (Boledo, Jackpot Lottery and Ordinary Lottery) have been paused and Cabinet, after considering the importance of the Government Lottery due to its cultural significance and tax revenues it generates, instructed the Ministry of Investment, which is currently responsible to regulate lotteries in Belize, to resume the operation of the Government Lotteries.

The Government of Belize will now administer the lotteries through the Belize Government Lotteries Limited (BGLL), a company newly established to administer, operate, and promote the Belize Government Lotteries. The Ministry of Investment is currently ensuring that all procedures, systems, equipment, and personnel are in place to operationalize BGLL.

BGLL is seeking four Master Agents¹ for the sale of lottery tickets for the Belize Government Lottery (Boledo, Jackpot Lottery and Ordinary Lottery). One Master Agent is needed for each of the respective geographic zones (Northern Zone- Corozal District and Orange Walk District; Eastern Zone- Belize District; Western Zone- Cayo District; Southern Zone- Stann Creek District and Toledo District). Disclaimer: Applicants cannot apply to be a Master Agent for more than one zone and Master Agents cannot be their own sub-agents.

- Boledo The lottery in which the winning number comprises two digits and is drawn in accordance with the provisions of sub-regulation (2) of Regulation 3 of the Lotteries Control Regulations;
- Jackpot Lottery The lottery in which the winning number comprises four digits and is drawn in accordance with the provisions of sub-regulation (2) of Regulation 3 of the Lotteries Control Regulation; and
- 3. Ordinary Lottery The lottery in which the winning number comprises the last two digits of the winning number of the Jackpot Lottery.

Below is a list of benefits that will be generated due to the Government directly administering the Belize Government Lotteries.

¹ Master Agent- will be responsible for the distribution, and sale of (only Boledo, Sunday Lottery and Jackpot Lottery) for any one of the respective geographic zones.

- 1. The Government Lottery sales will be made **electronic**.
- 2. Anyone interested can apply to be a sub-agent².
- 3. A lottery expert will be hired to audit and maintain the equipment, systems, and processes.
- 4. There will be a reduction of illegal lottery sales.
- 5. Increase in revenues and decrease costs of the Government lotteries using technology.
- 6. Increase in funding for the National Health Insurance (NHI) and Official Charities Fund (OCF).
- 7. Remedy of loopholes used for tax avoidance by the lottery sector.
- 8. Service provided will be of international industry standards.
- 9. Compliance with the Lotteries Control act and relevant laws.

Who can apply: A company with personnel who have a minimum of five years' experience in management and sales can apply and submit proposals. Marketing and sales experience in lotteries will be an asset. All shareholders of the company applying shall be "fit and proper" ³persons. Any applicant who was previously a license holder must have a history of full compliance with the Lotteries Control Act and Regulations.

How to apply: The Government would like interested parties to submit applications, Technical Proposals and Financial Proposals to be Master Agents for the sale of lottery tickets for the Belize Government Lotteries. All costs related to the preparation and presentation of the documents shall be borne by the applicant, therefore no claim shall be enforced against the Selection of Tenders Panel.

² Sub Agent- Agents that will work under the Master Agent to sell and distribute tickets to customers. A sub-agent will not be required to have a Bond.

³ "Fit and Proper" means, at a minimum, a person who is of good character and reputation, not a bankrupt, not convicted of an offence involving fraud or dishonesty and includes any other matter as the Lotteries Committee deems appropriate.

- If the applicant is selected to be Master Agent, the Bond must be executed before the agreement is signed.

In assessing submissions, preference will be given to Technical Proposals and Financial Proposals that:

• Portray the applicant's technical and financial ability to be a Master Agent of the Government Lotteries in their respective zone.

The successful applicants will be expected to administer the distribution, sale of lottery tickets and payment of prizes for the Belize Government Lotteries for one (1) year.
